From Pasadena to Stony Ridge Observatory - aprx a 40 minutes' drive:

210 Fwy west to Hwy 2 (Angeles Crest Hwy).

Exit at Angeles Crest Hwy. Turn right onto Angeles Crest Hwy.

Proceed to mileage marker 47.54 at Charlton Flats Picnic Area.

Turn right onto unmarked paved road, in short distance the road becomes graded dirt.

Continue .64 miles on dirt road to a wide area where you encounter a fork.

As Yogi Berra would say "Take it!" Actually, take the branch to the right toward the US Forest Service gate, normally locked, but open for scheduled visitors.

Continue through the gate, 0.3 mile to observatory driveway, turn right up to the observatory.

- ** If you are lost or need to call the observatory, there is a payphone at the Charlton Flats parking lot on Angeles Crest Hwy (ACH).


